As we all find ourselves at the beginning of December, again asking the question, "Where did this year go?" I thought it would be a good idea to take a quick measure of some of our success over the past 12 months. In particular, I think two programs speak volumes about what we as an agency, and each of you individually, quietly accomplish every day. Something you haven't heard about in the news of late, especially compared to its high profile in the preceding year, is the sex offender treatment center at the Corrigan-Radgowski Correctional Center. Predictions of peril for the Town of Montville if the facility were to open received an audience all the way to the State Capitol on more than one occasion. Legal action was undertaken and public hearings were held, all trying to block the 24 bed facility that would take 12 probationers from the Judicial Branch and 12 parolees from the Department of Correction.



## Successful Measures

The goal was to fill a critical gap in the reintegration of these offenders, which too often took them directly from incarceration back to the community with little support or supervision. As the old saying goes, no news is good news. The January Center as it is now known took in its first offender in February. Since then there have been no major issues, no impact whatsoever on the Town of Montville and most importantly the offenders who have completed the program have been given yet another set of skills to assist in combating recidivism. The end result, and the most important, is a further enhancement to public safety. An article in the Norwich Bulletin about the program in fact was headlined, "Feared Montville Sex Offender Facility Off to Quiet Start." I will take that as an endorsement any day.

Another program with the same qualities as the January Center for breaking the mold is the Driving under the Influence/Home Confinement Program, which has also been successfully growing since its implementation at the end of 2011. Given the public outcry in recent years to aggressively go after those who would drink and drive, it was a hurdle to suggest that you could attack the problem while not creating a collateral issue of destroying the livelihood and families of those who were arrested for DUI and required to serve mandatory periods of incarceration. But through the work of our staff and many other stakeholders, most importantly Mothers against Drunk Driving, the legislatively mandated program has now created a process where DUI offenders are accessed upon admission, and if appropriate placed on a treatment program that can allow them to continue to be productive citizens while serving their sentences at home. As of today, there is a program high of 138 offenders under the program's supervision with 214 offenders having successfully fulfilled its treatment requirements and completed their sentence. Again, it's not the public fanfare that's important. It is treating the problem, reducing the recidivism and improving public safety. Recently, Mothers against Drunk Driving honored the Parole and Community Services Division, DUI Home Confinement Program for its work in ensuring parolees are successfully transitioning into positive members of the community. These are just two examples of our success in 2012.

## A Warden's Gratitude

While many of you know that, Enfield Correctional Institution recently lost a devoted 19-year veteran officer, Ernest Douville, who was loved and respected by all who knew him.

I felt it was important to share with all staff that during this very difficult time for the staff here at Enfield CI, that the presence and support the administration provided to us was so deeply appreciated by myself and the staff here. I had offers from every facility in the state to include Central Office, from Directors, Wardens, Deputy Wardens, and with the support of NP-8, Captains and Lieutenants. Those who reported were assigned a post, which allowed my staff a chance to be a part of a wonderful tribute and celebration of Officer Douville's life.

While the list is too long to thank everyone individually, I would simply like to express my gratitude and recognize that what you all did that day was an extraordinary act of kindness. It was a wonderful reminder during times such as this, rank has no place and that we are all just a part of the DOC family.

## Reentry Resource Fair

The Chrysalis Center, Inc. hosted the "Second Annual Reentry Employment and Recourse Fair" which was held on Wednesday, Sept. 19, 2012 at the XL Center in Hartford. Collaborating partners included the State of Connecticut Department of Correction (DoC), Community Partners in Action, Community Solutions and STRIDE. The potential employees – all former offenders - were screened by the collaborating partners to ensure only appropriate candidates were registered in order to show prospective employers they were "employment ready". To prepare for the event, DoC Job Developer Joy Vouthounes, along with Job Center Counselors, worked to interview, update resumes, and screen candidates in various facilities, halfway houses

Almost 200 former offenders were registered for this private event and more than 30 employers and resource vendors participated. This was the second year that the Connecticut Convention Center participated in the event, for which they received an award for their continued support and commitment to the reentry initiative.

## Outstanding Educators


### Vocational Instructor of the Year

Congratulations are in order for Hospitality Technology Instructor Jean-Claude Ambroise for being selected as the Unified School District #1's 2012-2013 Vocational Instructor of the Year.

"Your students develop industry-specific skills, a positive work ethic, appropriate workplace decorum, and self worth," wrote Director of Career, Technical, Educational and Fiscal Services for USD #1 Caryn McCarthy in a letter informing Ambroise of his award. "That you were selected is a testament to the dedication and expertise you exhibit on a daily basis."

Ambroise, who brings more than 10 years of experience in hotel and restaurant management to his classroom, was initially hired as a GED instructor. He started the hospitality program four years ago, overseeing the construction of a mock front desk and hotel room inside his classroom.

As part of his being selected the Vocational Instructor of the Year, Ambroise was awarded \$1,000 in educational supply money for use in further enhancing his program.

## Veterans Old and Young Honored at Osborn CI

Representing a long past, but certainly not forgotten, war was 90-year-old World War II Army Veteran Charles Nash who spoke to a packed house of more than 70 inmates and staff.

Mr. Nash was among the thousands of American troops that stormed the beaches of Normandy on D-Day June 6, 1944. He was one of the youngest American soldiers on the beaches that day. During his five year stint in the Army, Mr. Nash also served in Africa, as well as supporting a regiment that liberated a concentration camp.

Representing our current day conflicts was Christian Carrier, a Navy Veteran, now serving in the Army National Guard who spoke about his experiences while serving on an aircraft carrier in the Persian Gulf.

Students and staff were both impressed and moved by the presentation.

"This was a remarkable program," said Unified School District #1 Principal Ed Korza, whose staff coordinated the program. "It brought this extremely important part of American history to life for our students."
