1. What is the approximate dollar amount of donations and pledges that your organization has received to date in response to the Sandy Hook tragedy?

\$65,000.00

Initially used for victims, balance to be used as scholarship fund for Newtown residents.

3. Approximately how much has your organization spent to date related to the Sandy Hook tragedy?

\$25,000.00

4. What services has your organization provided to those affected by the Sandy Hook tragedy? What populations or class of victims are being served by your organization in response to the Sandy Hook tragedy? What services does it expect to provide in the future?

Fundraising for families affected, Assisting with planning and payment for events for the affected families. We have reached out to 100% of the families to try and serve them. We hope to in the future provide as much assistance as possible to all victims affected by the 12-14-12 tragedy.

5. Has your organization provided funding to other organizations for purposes related the Sandy Hook tragedy? If so, which organizations have received those funds and what is the approximate dollar amount provided to them? How does your organization determine the need for funding?

We have provided fund raising for Embrace Hope of Newtown, a non-profit organization providing therapy to those affected during the 12-14-12 tragedy. Angels of Sandy Hook Elementary have been working directly with Scarlett Lewis, board member of Embrace Hope, who lost her son Jesse Lewis in 12-14 tragedy. We have raised approximately \$5,000.00 thus far for Embrace Hope.

6. Has your organization provided, or does it intend to provide, direct financial assistance to individuals, families or businesses for Sandy Hook relief? If so, what is the approximate dollar amount that your organization has proved to date and approximately how much direct financial assistance does it expect to provide in the future? How does your organization determine the need for assistance?

We do intend to continue providing direct financial assistance to individuals, families or businesses for Sandy Hook Relief. Thus far, we have provided approximately \$20,000.00 of direct financial assistance. We hope to provide at least an additional \$50,000.00. We determine the need for assistance upon request.

7. Does your organization have a plan in place on how to use any surplus funds not spent for purposes related to the Sandy Hook tragedy? If so, please describe that plan.

We will use any surplus as a scholarship fund for Newtown residents.
