Introduction To The Fire Service—Advanced Skills and Concepts (ASAC) builds on the skills learned in the Introduction to the Fire Service course. These students develop their own Command Staff and attend a series of lectures and practical skills stations on more advanced material, including High Angle Rescue, Vehicle Extrication, Self Contained Breathing Apparatus, Fireground Rehabilitation, Standpipe and Master Stream Operations and Pump Operator training. Students participate in leadership, radio communications and instructional methodology training sessions and each Squad is responsible for development and delivery of a company level drill. At graduation, the class responds to and mitigates a highly challenging simulated building fire, which involves a vehicle extrication, high-angle rope rescue, standpipe operations and a transition to a defensive attack. Students fill all fire-ground roles from Firefighter through Incident Commander, including two Pump Operators and one Aerial Operator who set up and operate the vehicles after they have been positioned.

All ITTFS courses are taught by a small, hand-picked and specially trained team of instructors. The environment that they create in ITTFS provides a safe, empowering, inclusive, positive, teamwork and character based learning experience. Over the years, participation in ITTFS has inspired graduates to become full members of their Fire Departments, seek out college opportunities within Fire and EMS and to earn positions as career Firefighters.

Accepted students will reside at the Connecticut Fire Academy for the duration of the class. Lodging, meals and some uniform items are included in the course tuition. Male and female ITTFS Instructors are on site 24 hours a day during each class.

The Department of Energy & Environmental Protection, Division of Forestry may have special grant funds available to assist a limited number of students in this class. - **Applications will be accepted from January 1 to March 27, 2020. Applications received after this date will not be accepted.**
- **Do not submit payment with the application.**
- **Accepted students will receive a paperwork package that must be filled out and returned no later than May 29, 2020 to continue in the acceptance process. Students that fail to meet the above deadline dates will not be considered for the program.**

APPLICATION REQUIREMENTS

- Applicants must be affiliated with a municipal Fire Department. **Application must be signed by Chief Officer.**
- Protective clothing is required for the program. Mandatory items include: helmet, bunker coat, bunker pants, structural gloves, work gloves, turnout boots, safety glasses and protective hood and an SCBA.
- Students must have transportation to and from the Connecticut Fire Academy.

- **ONLY APPLICANTS WHO HAVE COMPLETED THE INTRODUCTION TO THE FIRE SERVICE COURSE WILL BE ACCEPTED INTO ASAC.**

No faxes or copies will be accepted. Students who do not meet the above deadline dates will not be considered for the program.
