Legal Matters

Case Number 2017-1303 STEPHEN N PAPADOULIAS

Attorney Bryan Cafferelli presented this case. Commissioner Chisolm 'stepped down'. This case involved The Licensee is a pharmacist that has been investigated by the Drug Control Division for allegedly performing incompetent or negligent work, in violation of Section 20-579(a)(15) of the Connecticut General Statutes by dispensing the wrong medication to a patient. Proposed Resolution: This Settlement Agreement calls for a \$500.00 civil penalty, a Letter of Reprimand and completion of an additional five (5) hours of continuing education per year, for three (3) years from the date of the Settlement Agreement. The hours are in addition to the annual continuing education requirements for pharmacists and must be related to prevention and/or root cause analysis of prescription errors.

Commission Action: Commissioner Goodmaster moved, seconded by Commissioner Carbray and passed by a vote of 3-0 to accept and approve the aforementioned settlement agreement.

'First Time' Pharmacy Manager(s)

Commissioner DeFazio provided a summary of the responsibilities that a first-time pharmacy manager has and appreciated their appearance before the Commission. Commissioner DeFazio emphasized the importance of the pharmacy manager's role in contrast to the front-store manager (in many retail settings). Some responsibilities include leadership, technician registration, license renewals, and prescription error reporting.

Commissioner Chisolm provided a brief overview of the Med Watch program and discussed properly reporting prescription errors.
