In accordance with the CGS Chapter 400 "Salespersons means any individual who (a) negotiates or offers to negotiate a home improvement contract with an owner or (b) solicits or otherwise endeavors to procure by any means whatever, directly or indirectly, a home improvement contract from an owner on behalf of a contractor."

**Exception**: A legal entity that is registered as a home improvement contractor allows its corporate officers, members or partners to sell home improvement contracts on behalf of the legal entity.
