

Legal Entity Designee to Individual Broker - Reinstatement

All Applicants:

- > Complete the Legal Entity Designee to Individual Broker Reinstatement application.
 - If dissolving the entity, return the Connecticut broker license issued in the name
 of the entity and provide a copy of the Certificate of Dissolution filed with the CT
 Secretary of the State.
 - If there will be a change to the designated broker of the entity, the new designee must complete the Change of Designated Broker Application available on our website: www.ct.gov/dcp.

Fees:

- ➤ If previously licensed as an individual broker in Connecticut
 - **\$375.00** during odd-numbered years
 - \$383.00 during even-numbered years
- > If never licensed as an individual broker in Connecticut
 - \$565.00 initial license fee

Payment must be in the form of a check or money order made payable to: "Treasurer, State of Connecticut."

All broker licenses expire on March 31st
