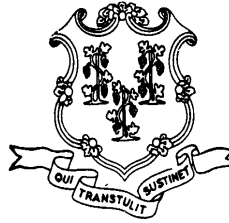

## **Reinstatement Instructions for Salespersons - Expired May 31, 2019**

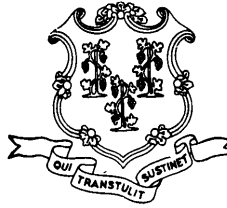
- A real estate salesperson's license may be reinstated provided a completed reinstatement form and all applicable fees are submitted **not later than two years after the date of expiration of the license**.
- Reinstatement of a salesperson's license will only be accepted if all applicable fees are paid to bring the license to the current year and required continuing education is complete. Any such reinstated license shall expire on the next succeeding May 31<sup>st</sup>.

### **Reinstatement Fees:**

- A total reinstatement fee of **\$313.50** must accompany the completed reinstatement application. Checks or money orders should be made payable to "*Treasurer, State of Connecticut*"
