Pursuant to the provisions of Section 4-166 et seq., 21a-7, and 21a-9 of the Connecticut General Statutes, the Department of Consumer Protection, hereinafter referred to as the "Department", having reason to believe that all of the following listed respondents, each hereinafter referred to as the "Respondent", has violated the provisions of Chapters 393 and 735a of the Connecticut General Statutes, the Department hereby issues its Complaint stating the charges regarding each licensee's failure to complete and furnish evidence of completion of such continuing education courses is a violation of Connecticut General Statutes, Sections 20-334d and 20-335 and the associated regulations and constitutes grounds for administrative action against each of the Respondents pursuant to Connecticut General Statutes, Sections 20-341, 21a-7, and 21a-9. In a letter dated January 22, 2019 to each of the Respondents, the Department notified the Respondents that it was in violation of the continuing education requirements and offered the Respondents an opportunity to show compliance with the continuing education requirements for the one-year period ending September 30, 2017. In the alternative, Respondents could apply for a hardship waiver or surrender his/ her license.
