Mr. Fusco appeared for guidance regarding the equivalent experience and training requirements for the (SM-2) Limited Journeyperson Sheet Metal license.

APPEARING FOR NEW APPLICATION:

David Skrzyniarz, Bristol, CT – (S-1) Unlimited Contractor

Mr. Skrzyniarz has submitted an (S-1) Unlimited Contractor application and would like to discuss a waiver of the (S-2) Unlimited Journeyperson license two-year requirement. Mr. Skrzyniarz passed the (S-2) examination on January 17, 2014.

Mr. Skrzyniarz did not attend this meeting; no action was taken.

APPEARING FOR RECONSIDERATION:

Kenneth Delnicki, Woodstock Valley, CT – (S-2) Unlimited Journeyperson – Denied The Board denied Mr. Delnicki's (S-2) Unlimited Journeyperson application at the August 20, 2015 meeting due to lack of apprenticeship.

Mr. Delnicki appeared and submitted additional documentation for the Board's review. After a review of the documentation and discussion, the Board determined that more

documentation is needed for proof of the required 8,000 hours of on the job training. The Board voted unanimously to deny Mr. Delnicki's (S-2) application due to lack of apprenticeship and on the job training.

Gary Edinger, Bristol, CT – (S-10) Unlimited Journeyperson – Approved with change in category

The Board denied Mr. Edinger's (S-2) Unlimited Journeyperson application at the August 20, 2015 meeting due to lack of apprenticeship.

Mr. Edinger appeared and submitted additional documentation for the Board's review. After discussion with the Board, Mr. Edinger chose to change the category of license sought from (S-2) to (S-10). The Board voted unanimously to approve Mr. Edinger for the (S-10) Limited Journeyperson examination.

David Sousa, Prospect, CT – (S-1) Unlimited Contractor – Approved

The Board denied Mr. Sousa's (S-1) Unlimited Contractor application at the August 20, 2015 meeting due to lack of the (S-2) Unlimited Journeyperson license for the required two year period. Mr. Sousa passed the (S-2) examination on July 23, 2015 and is requesting a waiver of this two-year requirement.

Mr. Sousa appeared and submitted additional documentation for the Board's review. After a review of the documentation and discussion, the Board voted to approve Mr. Sousa's (S-1) Unlimited Contractor application. Board Member Cameron Champlin opposed.

Henry Wasik, Berlin, CT – (D-2) Limited Journeyperson – Approved

The Board denied Mr. Wasik's (D-2) Limited Journeyperson application at the June 18, 2015 meeting due to lack of proof of apprenticeship, on the job training, and school related instruction, as required. Mr. Wasik submitted additional documentation for reconsideration at the August 20, 2015 meeting. After a review of additional documentation, the Board denied Mr. Wasik's (D-2) Limited Journeyperson application due to lack of apprenticeship and requested that he appear at the September meeting.

Mr. Wasik appeared and discussed his application with the Board. The Board voted unanimously to approve Mr. Wasik's (D-2) Limited Journeyperson application

The Board voted unanimously to deny Mr. Egan's (S-7) Limited Contractor application due to lack of proof of apprenticeship, on the job training, and related instruction.

Randall McPherson, Bellevue, WA – (D-1) Limited Contractor – Denied The Board voted unanimously to deny Mr. McPherson's (D-1) Limited Contractor application due to lack of (D-2) Limited Journeyperson license for the required two year period and lack of proof of apprenticeship, on the job training, and related instruction.

Mario Pannone, Jr., Cheshire, CT – (S-2) Unlimited Journeyperson – Denied The Board voted unanimously to deny Mr. Pannone's (S-2) Unlimited Journeyperson application due to lack of proof of apprenticeship, on the job training, and related instruction.
