# **APPEARING FOR GUIDANCE:**

George Kennedy appeared for guidance at the February 21, 2019 meeting regarding the application process for the S-2 Unlimited Journeyperson examination, at which the Board advised him to obtain additional documentation for proof of on the job training and apprenticeship hours completed and return to the next board meeting.

George appeared at today's meeting and the Board reviewed the original documentation submitted, as well as transcripts, an employment letter, and a statement from the Department of Labor.

After discussion, the Board noted that George is missing heating related courses and one year of registered on the job training, and informed George that he should contact the Department of Labor and obtain proof of the amount of S-2 registered apprenticeship hours he has credited, and comparative analysis of education for the S-2 related instruction requirement. He should return to the next board meeting with this documentation.

#### **APPEARING FOR GUIDANCE:**

Mark Burns appeared for guidance regarding his request for a waiver of the required 2-year period as an S-2 Unlimited Journeyperson holder for eligibility to sit for the S-1 Unlimited Contractor examination. Mr. Burns has held an S-2 license since April 1, 2019 and a B-2 license since December 10, 2011.

After discussion, the Board voted unanimously to approve Mr. Burns for the S-9 Limited Contractor examination upon the submission of an application acceptable to DCP standards.

#### APPEARING FOR DISCUSSION AND RECONSIDERATION OF S-2 APPLICATION:

Neal Alderman appeared for reconsideration of his S-2 Unlimited Journeyperson application at the November 8, 2018 meeting. Mr. Alderman requested to appear again

before the Board for further discussion and reconsideration of his S-2 application and previous denials of such application by the Department and the Board due to lack of proof of apprenticeship completion or notarized statements from employers showing dates and duties of employment under the supervision of a person holding the proper contractor license for the on the job work experience.

Mr. Alderman did not attend today's meeting.
