1. Occupational Boards Education Committee – This committee is being formed to establish the amount and type of experience and training required to establish an applicant for an examination for any license and will include members of the Electrical Work Examining Board, Heating, Piping, Cooling and Sheet Metal Board, and the Plumbing and Piping Work Examining Board. The first meeting will take place on August 28, 2019.
