LEGISLATIVE COMMITTEE:

1. Pending Mobile Home Park Regulations

The Council requested that Attorney Jerry Padula check on the status and report back to the Council at the March 15, 2017 meeting.

FINANCE COMMITTEE:

1. CHFA Programs

Individual Mobile Home Purchase Program

Norbert Deslauriers, CHFA Managing Director of Homeownership, appeared at the request of Bennett Pudlin and provided the Council with an update on CHFA's individual mobile home purchase program. The Council noted that, although there are currently buyers utilizing this program, they would like to see this program more widely publicized so that more buyers can take advantage of it.

Park Purchase Program

Mr. Deslauriers provided an update on the status of the Mobile Home Park Purchase Program. Attorney Pudlin reported that the Council has agreed to draft a document directing resident associations to the proper contact upon the closing of a park as soon as possible so that residents are informed of this option with sufficient time to act on it. Bennett Pudlin and Rafael Podolsky will draft this document and have it ready for review at the March 15, 2017 Council meeting.

2. Continued discussion regarding the publicizing of potential availability of infrastructure upgrade funding

Financing options such as CDBG (Community Development Block Grant) and STEAP (Small Town Economic Assistance Programs) may be available to assist parks with funding for large infrastructure projects and it would benefit park owners to receive notifications of such funding as it becomes available. Discussion took place regarding the most efficient way to relay notices of availability of funding to park owners who may be interested in applying for these funds.

1. State Representative Betty Boukus

The Council noted the passing of State Representative Betty Boukus and acknowledged her many contributions to residents of the State of Connecticut, in particular, her support for mobile manufactured homes in Connecticut.

1. Letter from Theodore Doolittle, DCP to Bennett Pudlin, Mobile Manufactured Home Advisory Council, dated November 10, 2016

This letter is in response to the Council's interest, as expressed at the October 19, 2016 Council meeting, in getting more information regarding the Department's practices concerning inspection for the marking of lot boundaries at mobile home parks. DCP OCCUPATIONAL ENFORCEMENT UNIT:

1. The Council will review the complaint report submitted by the DCP Occupational Enforcement Unit, including open, closed, and dismissed cases

The Council reviewed the complaint report, which had been tabled from the October 19, 2016 meeting, and stated that they would like to see complaint reports be more informative. The Council requested a complaint report and inspection report at least twice a year.

2. The Council will review the inspection report submitted by DCP Occupational Enforcement Unit (See above)

3. Continued discussion on the demarcation of lot boundaries within parks

The Council reviewed a letter dated November 10, 2016 (See "Correspondence") on this topic and thanked the Department for providing this clarification for park owners who are concerned about recent correspondence in relation to unmarked lot boundaries they had received from the Department after the completion of recent inspections.

The Council noted that the letter was shared with those in attendance at the Connecticut Manufactured Housing Association Annual Meeting (CMHA) on November 10, 2016, and

that the letter helped owners to understand what steps are required of them to be in compliance with marking of the boundaries.
