OLD BUSINESS:

1. Continuing Education Curriculum for the 2018-2019 cycle

After a review of the curriculum, the Board voted unanimously to accept the 7-hour 2018-2019 Continuing Education Curriculum for P1/P2 license holders.

The Board reviewed and discussed a working draft copy of a document outlining subject matter for consideration for the 2020-2021 continuing education curriculum submitted by Frank DaCato.

2. Request for exemption to Well Drilling Laws due to hardship submitted by Craig Kazemekas for property located at 10 Cedar Ave., Wolcott, CT, as discussed at the November 14, 2017 Plumbing and Piping Work Examining Board meeting. This request is pending review by the Raul Rodriguez, Assistant Attorney General.

The Board reviewed the response from Assistant Attorney General Raul Rodriguez dated December 1, 2017 regarding potential liability if the Board were to approve this request. Ryan Tetreault and Sean Merrigan from the Department of Public Health (DPH), as well as Mary Creaser and Maura Esposito from Chesprocott Health District were in attendance to discuss this request for exemption with the Board.

After discussion, the Board voted unanimously to allow a variance to drill a new well on the property located at 10 Cedar Ave., Wolcott, CT under the direction of the Acting Director of Health.

NEW BUSINESS:

1. Request for exemption to Well Drilling Laws due to hardship submitted by Patricia Beale and Richard Dickau for property located at 1414 Spindle Hill Rd., Wolcott, CT

Those present reviewed the request for hardship and related documentation. After discussion, the Board voted unanimously to allow a variance to drill a new well on the property located at 1414 Spindle Hill Rd., Wolcott, CT under the direction of the Acting Director of Health.

Legislative Program Director O'Brien was present and took place in a discussion regarding the drafting of proposed changes to the well drilling regulations in order to resolve these issues going forward.
