D-New Items

D-1 Excerpts from Chapter 613a regarding limited liability companies-effective July 1, 2017. (Dist. 4)

Sec. 34-243a- The chapter defines a “professional service”, which means any type of service to the public that requires members of that profession rendering such service to obtain a license or other legal authorization as a condition precedent to the rendition thereof, limited to the professional services rendered by dentists, naturopaths, chiropractors, physicians and surgeons, physician assistants, doctors of dentistry, physical therapists, occupational therapists, podiatrists, optometrists, nurses, nurse-midwives, veterinarians, pharmacists, architects, professional engineers, or jointly by architects and professional engineers, landscape architects, real estate brokers, insurance producers, certified public accountants and public accountants, land surveyors, psychologists, attorneys-at-law, licensed martial and family therapists, licensed professional counselors, licensed or certified alcohol and drug counselors and licensed clinical social workers.

Sec.34- 243-h (c) - This subsection is in regards to a limited liability company which may be formed to render professional services, provided: (1) Each member of the limited liability company must be licensed or otherwise by law in this state or any other jurisdiction to render such professional services; (2) the limited liability company will render only one specific type of professional services and services ancillary to such professional services may not engage in any business other than the rendering of professional services for which it was formed to render and services ancillary to such professional services; and (3) the limited liability company may render its professional services in this state only through its members, managers, employees and agents who are licensed or otherwise legally authorized to render such professional services within this state.

D-2 Regulations-Surveys and Map Standards (Dist. 3)

Jerry Padula, staff attorney for the Department appeared before the Board in regards to the Department’s revised Regulations Concerning Survey and Map Standards. This version includes changes provided by the Office of the Governor resulting from their review. The question the Department had for the Board is why they had chosen to delete the existing subsection (b) within Section 20-300b-6 “General Location Survey” which read: “This type of survey shall not be used to prepare property descriptions for conveyance.”

Attorney Padula stated that if the Board had any questions or comments, to forward them to him, Julianne Avallone or Leslie O’Brien by the end of January.

Chairman D'Andrea stated that the surveyor members discussed this via email and forwarded their comments.
