APPLICATION FOR REIMBURSEMENT FROM THE NEW HOME CONSTRUCTION GUARANTY FUND

INSTRUCTIONS:

Applications for reimbursement from the guaranty fund must be a minimum of twenty-five (25) days old, but must be received within 2 years from the date of the judgment and must be accompanied by all required supporting documentation. Applicants are only eligible for reimbursement from this fund if their contract was signed on or after October 1, 1999. The <u>maximum</u> amount paid to each consumer is \$30,000 per contract.

You must provide the following documentation to substantiate your claim:

- 1. Copy of your new home construction contract;
- 2. CERTIFIED copy of the court judgment;
- 3. Copy of Writ of execution (<u>BOTH Bank and Property</u>) including statement from officer executing same, if applicable;(Superior Court Judgments Only) and;
- 4. If bankruptcy discharge, a <u>certified</u> copy of the Discharge of Debtor Notice including the schedule in which you are listed as a creditor.
