DDS RESPONSE TO NOVEL CORONAVIRUS

The Department of Developmental Services (DDS) has been closely monitoring the recent developments regarding the outbreak of a coronavirus (Novel Coronavirus) in China, after the U.S. Centers for Disease Control and Prevention (CDC) announced several confirmed cases in the United States.

DDS advises qualified providers and their employees to adhere to universal precautions and the additional recommendations outlined below. Employees should notify primary care providers or hospital medical professionals of any individual who has recently traveled to China and has developed upper respiratory symptoms. Qualified providers also should notify the DDS Regional Health Services Director and the DDS Director of Health and Clinical Services at the Central Office of any suspected cases of the Novel Coronavirus.

Coronavirus, colds, influenza (flu), and other respiratory viruses are spread through the air and by touching contaminated surfaces or objects. Please adhere to the following recommendations:

- 1. Universal Precautions.
- 2. Thoroughly wash hands with soap and water for at least 20 seconds.
- 3. Cover your nose and mouth with a tissue when you cough or sneeze. Throw the tissue in the trash and then wash your hands.
- 4. Use alcohol-based hand sanitizer, if soap and water are not available.
- 5. Avoid close contact with people who are sick.

Unless contraindicated by a healthcare provider, employees and individuals receiving services from DDS are encouraged to receive the seasonal Influenza vaccine.

DDS defers to the Centers for Disease Control and Prevention (CDC) and CT Department of Public Health (DPH) for the most current information, updates and recommendations regarding the Novel Coronavirus.
