Advertisement: Canterbury Female Boarding School

The advertisement announced that the school would be reopening on April 1, 1833 for the "...reception of young Ladies and little Misses of color."

Vermont Chronicle, 3-13-1833 (Volume VIII, No. 11)

Headline: The Canterbury School

The article is a reprint of one that first appeared in the *Norwich Courier*, signed by the "Civil Authority" and "Select Men" of that town. It discusses the town meeting held on March 9, 1833 in Canterbury. Vermont Chronicle, 4-26-1833 (Volume VIII, No. 17)

Headline: Miss Prudence Crandall

The article describes Miss Crandall's determination to keep the academy open.

Poulson's American Daily Advertiser, 7-2-33

Headline: Shame on Connecticut

The article informs the public that Prudence Crandall has been arrested and imprisoned for operating a school to educate "colored youth."

Vermont Chronicle, 7-12-1833 (Volume VIII, No. 28)

Headline: Miss Crandall Imprisoned!

The article describes the arrest and jailing of Prudence Crandall for violating the Black Law. Farmer's Cabinet, 7-19-33

Headline: Connecticut Law

The article reprints sections of the Black Law, but indicates that because of the law's ambiguity, it is in essence unconstitutional.

Vermont Chronicle, 7-21-1833 (Volume VIII, No. 25)

Headline: The Canterbury School

The article is a reprint of a portion of a pamphlet the Editor of the *Brooklyn Unionist* newspaper sent to the *Vermont Chronicle* newspaper containing a letter from Prudence Crandall. The letter discusses her reasoning for changing the academy's student body. The editor is of the opinion that if she had simply allowed Sarah Harris into the school, and hadn't attempted to attract additional black students, the reaction from the public would have been much less severe.

Headline: The Trial of Miss Crandall

The article is a reprint of one that first appeared in the *Connecticut Courier* detailing the proceedings of Crandall's first trial which took place in Brooklyn, Connecticut, the county seat at that time. Vermont Chronicle, 8-30-1833 (Volume VIII, No. 35)

Headline: Case of Miss Crandall

The article is a reprint of one that first appeared in the *Brooklyn Unionist* newspaper discussing the second trial of Prudence Crandall before the Supreme Court of Connecticut with Judge Daggett on the bench.
