FINAL DECISION

A hearing was held on July 21, 2005 at the Department of Environmental Protection Marine Headquarters in Old Lyme regarding the suspension of the right of Edward G. Mezger to operate a vessel in the waters of the State. General Statutes §15-140q. Mr. Mezger and the arresting officer John Hey were present, as was Eleanor Mariani of the DEP Boating Division. Mr. Mezger was arrested on June 26, 2005; a Suspension Notice was mailed to him on June 27, 2005, advising him of his right to a hearing prior to the effective date of the suspension to determine probable cause for said suspension.

FINDINGS OF FACT

Following this hearing, I find the following:

- (1) There was probable cause to arrest Mr. Mezger for operating a vessel while under the influence of intoxicating liquor;
- (2) Mr. Mezger was placed under arrest;
- (3) The results of two timely breath tests indicated that at the time of the alleged offense Mr. Mezger had an elevated blood alcohol count (BAC) of .125% (first test) and .114% (second test); and
- (4) Mr. Mezger was operating the vessel.

I also find that this was Mr. Mezger's first offense.

CONCLUSION AND ORDER

Having found the factors listed above, I find that there is probable cause to suspend Mr. Mezger's privileges to operate a vessel in the waters of the State of Connecticut. Therefore, under the provisions of General Statutes §15-140q, as of the date of this decision, the Commissioner of Environmental Protection hereby suspends the right of Edward G. Mezger to operate a vessel in the waters of the State for 90 days. This suspension is retroactive to the Date of Mr. Mezger's arrest, *June 26*, 2005 to September 24, 2005.
