Proof of attendance to an educational event approved by CT DEEP's Division of Forestry must be submitted in order to receive CEU's. The only proof accepted by the Division of Forestry is an <u>original</u> Certificate of Completion from the course or workshop sponsor that contains the following information:

The title of the course or workshop
The date it was taken
The name and certification number of the attending practitioner
An original signature from a representative of the course or workshop sponsor

Certificates of Completion should be attached to the Annual Report being submitted.

It is the responsibility of the practitioner to obtain a Certificate of Completion from the course or workshop sponsor and submit it to CT DEEP's Division of Forestry. The Division of Forestry staff will not obtain and submit this information for you.

Note that all educational events must be evaluated and awarded CEU's by the CT DEEP's Division of Forestry before CEU's are granted. For events that have already been awarded CEU's, you only need to submit the Certificate of Completion as proof of attendance. For events that have <u>not</u> been awarded CEU's, you must submit proof of attendance AND a **copy of the event's program or agenda**. The agenda must include the program title, date held, length of the program in hours, the instructors name, the program sponsor, and identify a contact person.
