## How To Order FEMA Flood Insurance Rate Maps (FIRMs)

Overview	<ul> <li>Many different users – such as private citizens, insurance agents and brokers, local community officials and lending institutions – use flood maps in a variety of ways, including:</li> <li>Determining the extent of special flood hazard areas;</li> <li>Determining if a specific property or building is located in the flood risk zone;</li> <li>Determining if flood insurance will be a requirement on a loan;</li> <li>Aiding in the proper administration of local floodplain management regulations and programs; and</li> <li>Determining the proper and feasible preventative measures which homeowners and local communities can use to help reduce/prevent flood damage losses.</li> </ul>
Ordering Maps	There are four ways to order Flood Insurance Rate Maps and Flood Insurance Studies from the FEMA Map Service Center (MSC):
	<ol> <li>Order Online — To place an order on the internet, go to <u>http://www.msc.fema.gov</u> and follow the directions provided. A property address can be entered and the corresponding map will appear and an option for purchase given.</li> </ol>
	<ol> <li>Order By Phone — To order by phone, call the MSC toll-free Monday through Friday from 8:00 a.m. to 6:00 p.m. (Eastern Time) at 1(800) 358-9616.</li> </ol>
	<ol> <li>Order By Fax — To order by fax, print a copy of the MSC Order Form at <u>http://www.msc.fema.gov</u> (located in the middle of the page under the heading <i>How To Order</i>). Fill out the order form and fax it to the MSC Fax order line at 1(800) 358-9620.</li> </ol>
	4. Order By Mail — To order by mail, print a copy of the MSC Order Form at <u>http://www.msc.fema.gov</u> (located in the middle of the page under the heading <i>How To Order</i> ). Fill out the form and mail it to the MSC at the following address:

Products and Prices	Paper Flood Insurance Rate Maps (FIRMs), including index maps, cost \$4 per panel. Shipping is \$0.41 per panel for the first 10 panels plus \$0.10 for each additional panel.
	Paper Flood Insurance Studies (FIS), cost \$9 per study volume, plus an additional \$4 for each Floodway Map. The shipping & handling charge is \$5 for the first FIS, plus \$0.50 for each additional FIS. No shipping & handling is charged for Floodway Maps.
