Technical Work Group – Scott Wright reported:

They are working on Fire Task Force options, information about the West Hartford and New Britain Systems and also looking at a low power channel for convoy/travel communications STOCS changes are underway due to interference issues further information will be provided later in the meeting on the R1 and R2 notification network proposal

Broadband Wireless Working Group

Members with approved FirstNet State Plan access meet with FirstNet/AT&T on Thursday September 19, 2019 to receive a quarterly technical update specific to Connecticut. Discussed were proposed site status in Western Connecticut, deployable Co-Ams for State Assets, small cell sites along the shoreline

CMED Working Group – Betty Morris reported the group met October 9, 2019 and continues to work on a directory and maps for end users and also working on the forward movement of patients. Significant events July-October 2019:

Keith Victor reported: AUX COMM Class DESPP November 16-17th VT is hosting a COMT Class RI is hosting a COML Class

Air Operations Communications Working Group – No report.

Maritime Communications Working Group – Bob Drozynski

Ongoing efforts to include communications center information for shoreline municipalities and also municipalities along the Federal Channel on the Connecticut River to Hartford.

FCC Region Updates Region 19 - No report

Regional Reports

Region 1 – Chip Vitone – ESF #2 meets monthly. R1 ESF #2 supported the Sikorsky exercise for communications. Cell phone calls were plotted and one was found to be 12 miles off. November 7th presentation from Coast Guard for 9-1-1 call takers. Field COMM 1 will be out of service for 2-3 weeks for modifications.

Region 2 – Jared Heon reported ESF #2 met 9/25 in Orange and will meet in Wallingford 10/23/19. 2018 and 2019 HSGP funding is being used to purchase control stations. Funding has been secured for a TICP update with full inventory of the systems. EFS #2 is assisting ESF #10 (Haz Mat) with planning for radio acquisition.

Region 3 – Keith Victor

MCV #3 was deployed to Bradley for the airplane crash, COML and COMTs got the STOCS system set up. There was a Wi-fi issue with too many users.

Task Force communications in route were an issue

4 STOCS boxes were set up did not need them all and had to be changed

The disparate task force entities did not have inter ops comms and did not know how to switch over

Hartford is configuring their P-25 system.

West Hartford Police are switching to P-25

Region 4 – No report

Region 5 – Al Russo

MCV 5 deployed 3 times, Public Safety day in Ridgefield included inter ops communications training, event at WCSU tied CSP-Security and FAPRN together, ICS-205 submitted

Assisted with Waterbury Water Resource issue – tied together LMR console and NWPS ISSI connection to increase portable radio coverage.

Tribal Nations – Rich LaSaracina nothing significant to report

Federal Government – Chris Tuttle National InterOp Interference

Used the FCC in New York and Pennsylvania to check on issues. Direction finding located 17 sites with issues on UTAC and 7 Tac, these had major effects from Boston to Philadelphia. Be mindful of your usage of secondary use of low power UTACs. FCC has a on-line portal for reporting public safety interference.

Currently NY, NJ, PA, and CT are engaged in a 4 state planning effort. Scott Wright represents CT, looking for more representatives.

Technical Assistance Request submitted by CT for 2020 SCIP update.

FirstNet – Gary McCarraher reported on the FirstNet Board voted on reinvestments. Funds will go to the CORE, 5G updates, increase the number of deployables. It is expected in Spring 2020 AT&T will announce technology upgrades.

Planning is underway for a one day meeting in Connecticut to provide Roadmap information and helpful information for end users.

Old Business:

Addition of AUX COMM to existing COMU credentialing Policy.

Presented at September meeting for review until the October meeting.

New Business:
