Jacob Manke

A. Jacob introduced Nicole Vilardi, a State of CT Police Dispatcher, and an Intern.

- B. EMAP accreditation DEMHS is looking at a long term RESP and LEOP planning initiative to integrate the FEMA Community Life Lines concept.
- C. EPPI will be regional table-top exercises this year for EMD's and CEO's. The first exercise will be on November 18, 2019 at Branford Fire Department Day Delivery, followed by November 21, 2019 at Haddam Fire Department Evening Delivery.
- D. Please log into WebEOC and keep abreast of the changes, there will be upgraded pages and new information on the Log In Page.
- E. DEMHS issued new Standard Operating Procedures and forms for :CERT MRC activations.– please send Jacob your forms (in landscape form) and he will respond DART / ESF-11 (Animal Protection) unit will be doing their canine distribution in New Haven.
- F. CTIC Intelligence Center has asked that municipalities report any cyber-attacks to them after notification of their Local Police Departments. The quicker the data to CTIC, the better the response.

- D. Train the Trainer classes on October 19, 2019 and October 26, 2019.
- E. ID tags are still a problem.
- F. Hamden CERT training complete.
- G. Milford CERT -speakers reviewed VOST and Next Door apps.
- H. UNH welcomed 18 new CERT Team members.
- I. Wallingford has a CERT Basics Course planned for October.

A. Torrance lead the discussion about the 2019 HSGP Grant. Torrance explained the project requests and presented a worksheet concerning the 2019 ALCRA Available Funding.

B. Each ESF presented their projects.

C. There was a discussion about ESF 13 – Ballistic Vest Replacement \$35,000 concerning Bomb Squad regional teams.

Grand Total \$100,947 A discussion followed concerning using the above funds.

Rick Fontana made a motion to accept all of the projects except the \$69,624 for the ESF 10 HAZMAT 30 Tac Comm Portable Radios. Mike Maglione seconded the motion. A discussion followed asking for ESF's to prioritize the projects and to have some money available for equipment maintenance. A discussion followed.

Roasa was asked to prioritize the 4 Bomb Squad projects. The priorities are

#1. Night Vision -	\$17,200
#2. Response Vehicle –	\$56,185
#3. 2 Set Bomb PPE -	\$65,816
#4. Vessel, Disposal, Incineration	\$31,849

In order to align the project costs and the total for the 2019 budget, a suggestion was made to take projects and add them to 2017 HSPG or 2018 HSGP budgets:

- 1. ESF 3 Public Works Mobile signs for \$ 18,430 was removed from the 2019 budget.
- 2. ESF 10 HAZMAT 30 Tac Comm Portable Radios for \$69,624 was removed from the 2019 budget.

3. ESF 13 Law Enforcement – Ballistic Vest Replacement for \$35,000 was removed from the 2019 budget.

The revised motion from Rick Fontana was made for the above projects totaling \$122,430 to be removed from the 2019 budget and to be added to 2017 and 2018 budgets. Mike Maglione seconded the motion. All approved unanimous.

- 4. A suggestion was made to calculate the available funds from 2017 and 2018 and use those funds for some of the proposed projects. The total of available funds from 2017 and 2018 is \$98,000.
- 5. A motion was made by Jared Heon to form a subcommittee for ESF 5 for School Safety & Security. The point of contact will be Jeff Neilson from Milford Public Schools. The motion was seconded by Mike Maglione. Motion passed unanimous.
