A. ESF 1 – Transportation (Jean Davies)

Jean Davies explained that she is working a pilot project for information distribution on touch screen technology for agriculture and food systems. The pilot does not have an emergency management aspect except that it could possibly be used for emergency management information. There is no funding involved because of a grant that was secured.

B. ESF 2 – Communications (Jared Heon/Frank Kiernan)

- A. PSAP Jared Heon talked about a letter that will be going out to all of the PSAP directors to explain the project and establish contact people. They will then start going out and see what people have. The process should be quick.
- B. TIC plan information on accountability of the project and explaining what is happening.
- C. Regional radio reprograming has received the radios, Jacob has done inventory on them. Have been told that the reprograming costs will have to be added to the budget. The radios have to be looked at to see what has to be done before a price can be calculated. If these radios are not immediately reprogramed, there are other radios that are capable of doing the same thing. There are presently 15 of the 21 radios accounted for. Jonathan Mulhern said that the radios were beneficial for the Federal and State agencies working with local police and were used for large events. A discussion followed.
- D. Jared said that they are going to be hosting 4 trainings, dates to be determined at the December meeting. There will be a valley training, a New Haven training, a Valley Shore area training and a Wallingford training.
