1. Call to Order, Pledge of Allegiance, Introduction, Establish Quorum

The meeting was called to order by Chairman Bill Richards at 9:33 a.m. the Pledge of Allegiance was done; a quorum was established with 14 voting members.

2. Acceptance of REPT SC minutes: December 20, 2019, regular meetings. Susan Shaw made a motion to accept the minutes from the December 20, 2019 regular REPT Steering Committee meeting. Douglas Edo seconded the motion. Motion passed.

3. Fiduciary/ Lead RPO Report (RiverCOG's Torrance Downes

- A. Torrance Downes explained that RiverCOG's computers had been hacked and he explained the process of what RiverCOG has gone through. Torrance will be presenting at the Regional Collaboration Meeting to explain in lay-man's terms what the RiverCOG has learned and an after action report.
- B. 2017 HSGP Grant expires at the end or April 2020. The IMT mobile satellite dish is still outstanding. It is questionable that this work can all get completed before end of April. Torrance is looking into the possibility of reallocating the \$30,000 for other purchases. There are items that might be reprogramed from the 2018 grant using the \$30,000. Bob Dryozinski commented that it might be an opportunity to do this.

A motion was made by Steve Dudley to authorize Torrance Downes to spend \$30,000 for previously approved 2018 projects totaling \$30,000., as long as they can be completed before the April deadline. The motion was seconded by Jim Buck. A vote was taken and motion passed unanimously.

- C. Approximately, \$2,387 remains in the Bomb Squad budget. Rosa Melendez is working on using those funds before the April deadline.
- D. 2018 HSGP Grant expiring April 2021. Other than what was talked about earlier, the 2018 funds have completely been used.
- E. 2019 HSGP Grant expires April 2022. Most of the allocated funds remain unspent. Two fit-testers for ESF-4 have been purchased and delivered.
- F. 2018 EMPG/NHASH Grant expires June 2020. Approximately \$48,000 of the \$60,000 remains. The additional funds will be spent before the expiration date.
