
Dear Ms. Keenan:

I have been asked to respond to your order re Interrogatories relative to the Cedarhurst Association Inc. Water Company.

In this regard the Town of Newtown ("Town") respectfully requests that the above referenced order be withdrawn as to the Town. The Town does not have any interest in succeeding to the Cedarhurst Water Company, nor does it have the resources or personnel to do so. The Town owns one water company (Fairfield Hills Water Company) which is operated by a professional systems operator. It acquired the Fairfield Hills Water Company as part of the acquisition of the former Fairfield Hills Hospital from the State of Connecticut. Furthermore, the Town's system is not the closest to the Cedarhurst system.

Therefore, I reiterate my request to withdraw the interrogatories as against the Town.
