

Aquarion Water Company	11/8/16; revised 1/6/17	Initially claimed unserved areas in Chaplin, Eastford, Hampton, and Scotland; revision removed lands claimed by DEEP and claim to Scotland
Connecticut Water Company	11/8/16	All or portions unserved areas of Ashford, Brooklyn, Canterbury, Killingly, Plainfield, Pomfret, Thompson, Union, and Woodstock
Connecticut DEEP	12/9/16	Agency-owned and maintained state conservation lands except those provided with water service from another public water system or utility
Jewett City Water Company	11/8/16; revised 1/11/17	Initially claimed all unserved areas in Canterbury, Scotland, and Plainfield; revision removed lands claimed by DEEP and reduced claim to portion of Canterbury and Plainfield
Putnam WPCA	12/14/16; revised 12/29/16	Initially claimed all unserved areas in Putnam, Woodstock, Pomfret, and Thompson; revision removed lands claimed by DEEP, removed claim to Pomfret, and restricted service in Woodstock and Thompson to existing service areas
Sterling Water Co.	1/11/17	All unserved areas in Sterling except those lands claimed by DEEP
Windham Water Works	12/2/16; revised 12/15/16	Initially claimed all unserved areas in Windham; revision removed lands claimed by DEEP


