#### **Rivers Alliance Comments**

- Questions related to narratives
  - ✓ Town-by-Town approach does not identify donor basins and recipient basins
  - ✓ Could water utilities be identified with donor and recipient basins
  - ✓ Reader cannot find the most salient points
- Future Sources and Interconnections
  - ✓ Interconnection table inconsistencies
  - ✓ Interconnection reciprocity inconsistencies
  - ✓ Many water utilities state that additional water is needed

May be able to address this with a narrative

May be able to address this with a summary table

These points are emerging through the review process, and text will be added

We can provide clean-up

We are aware; these are points that underscore the importance of the planning process and the integrated report




### DPH Request – CPCN Application



# CPCN Application for 165 Hartford Pike (Route 101), Dayville (Killingly)

- Phase IA approval issued April 2015
- Phase IB approval issued March 2016.
- Phase II approval issued in May of 2016.
- Final well use approval/certificate is being held pending the WUCCs recommendation.
- Site is located approximately 0.5 miles from CWC - Crystal System.
- Average Daily Demand is 1,470 gallons. A deli and office space will occupy the 4,000 SF building.
