REQUEST BY REJA ACQUISITION CORP. TO CEASE OPERATING AS A WATER COMPANY WITH RESPECT TO THE RAINBOW SPRINGS WATER SYSTEM IN MIDDLEFIELD, CONNECTICUT

Dear Commissioners:

In January 2014 the departments rendered a final decision in the above entitled docketed matter. Relevant hereto, Order No. 10 of said decision required that:

Within six months after the transfer of the West Service and Valley View water systems to Aquarion, REJA shall file with the Departments a request to cease operations as a water company with respect to the Rainbow Springs water system in Middlefield, Connecticut. Until the Departments grant REJA's request and order a suitable entity to take over the Rainbow

Springs water system, REJA shall comply with all the statutes and regulations applicable to water companies and water systems.

The transfers of the West Service and Valley View water systems to Aquarion were done on April 10, 2014. Now, in accordance with said Order #10, and also pursuant to the applicable statutes and regulations, including but not necessarily limited to section 16-46a and section 16-262n of the general statutes, REJA Acquisition Corp does hereby make request to the Departments to cease operations as a water company with respect to the said Rainbow Springs water system in Middlefield, Connecticut.
