- Connecticut Children's was funded by HUD
 - \$2 million for Housing
 - \$3 million for Lead Hazard Control
 - Using the web-based rating system

• Judy Dicine

- Public Act 13-132 Blight Task Force has been formed
- Chief State's Attorney assigned Judy (who was willing) to be on the task force
- Will be meeting to come up with
 - Model ordinance for municipalities
 - How to help communities with blight
- o Police chief's see the value of this and are excited
 - Healthy Homes relates to Crime
- There are varying definitions of blight throughout CT. Depends on the town.

Mike Gurecka

- Discussed funding
 - DEEP Draft Decision 2013-2015 Conservation & Load Management @\$220 million annually (\$183 million electric & \$43 million gas)
 - HES (Market Rate) @\$37 million over next 3 years
 - HES Income Eligible @\$30 million over the next 3 years
- DEEP pursuing new Energy Auditing Tool for the DOE/WAP
 - Oakridge National Lab NEAT Audit will include HH
- Dept of Energy late July, grantee meeting in Denver
 - \$500,000 for CT DOE/WAP to assist 48 units
 - Home Performance Network /ANSI Licensing Standard
 - Quality Control Inspector (Required 2014)
 - Energy Auditor (Required 2015)
 - Lead Technician (Required 2015)
 - Retro Fit Installer (Required 2015)

- Weatherization Plus Health
 - UI/CL&P working with DPH on Radon Testing Pilot (potential liabilities)
 - Pilot study to have state lab perform analysis of radon
- o HIA July request to present to the 2nd National Impact Assessment
 - Presenting team of: Megan Sandler (National Center for Medical Legal Partnerships), Lynn Snyder NASCSP (National Office), Ellen Tohn (Tohn Environmental Strategies), Mike Gurecka (NOI), & John Horvath (National Consumer Law Center)
 - Presentation on September 24th Washington DC.
- o New Opportunities \$250,000 grant from DDS
 - Focus on trips & falls with DOE Weatherization Plus Health
 - CDC curriculum for injury prevention
 - Checklist on Safety
 - Barriers: eligibility, national program goals
 - Reached out to Anthem Blue Cross and possibly member of advisory group and potential preventative care provider
- Deb Olson CHFA
 - o Governor given \$ for Housing
 - Identified radon after home was weatherized
 - Changes in scope of work to remediate the radon
 - New requirements: to test for mold (visual) and radon prior to applying for funding
 - Ron Kraatz question: maybe move to more of a Healthy Homes assessment requirement?
 - CT Zero Energy Home pilot study with Bill Bell
 - Identified radon after home was designed as a zero energy home
 - To remediate would negate the zero energy home designation
 - Speaking with local architects to see how to remediate this and to avoid this in the future
 - May not be able to maintain the designation of a zero energy home

- Alan Buzzetti
 - All homes were tested for radon in the last grant round
- Allison Sullivan
 - Radon Resistant New Construction (RRNC) seminar
 - Geared toward contractors that would be building the homes
 - There is a need for outreach to contractors about RRNC
 - RRNC rarely done correctly by CT builders
 - Judy Dicine presenting to building officials and would give any radon info and speak to support our attempts to put RRNC into building code in CT
- Deb Dozier
 - NauVel success story
 - During abatement of an EBLL the utility company performed weatherization on the home that included new insulation
 - Referral to CHIF Cal Vinyl for possible additional assistance
 - Weatherization will be using the DOE Home Energy Scoring
 - o NauVel 1st HH coalition meeting in March
 - 8-9 people: Section 8, UI, CL&P, Birmingham
 - Next meeting in October
- Kim Ploszaj
 - HH coalitions
 - Bridgeport website development, promoting the concept of HH, videos
 - Waterbury community partners, UCONN ed materials, health workers
 - New Haven just starting out (Tina McCarthy), pulling funding sources together
- Sabine Kuzco (absent)
 - Moving forward with expanding the City's Healthy Homes website
 - Will bring the information to our next meeting.
 - We are also working on several videos (proper nutrition, hand washing, contractor compliance, cleanliness)..

- With the BLFF's new award, we received \$ 200,000 for Healthy Homes initiatives; any unit where we will conduct lead remediation, we will do a Healthy Homes assessment, and just like LAMPP, we will now use the Rating Tool


