

<u>BREAKING DOWN THE</u> <u>STATUTE</u>


Overdrives, drives when overloaded, overworks



Deprives of <u>necessary sustenance</u>



Cruelly Beats or Kills Or Unjustifiably Injures




Having impounded or confined and fails to give proper care



Neglects to cage or restrain animals to prevent injury to themselves or other animals



Fails To Supply With <u>Wholesome</u> <u>Air</u>, Food, or Water



Unjustifiably administers or exposes poisonous or noxious drug or substance with the <u>intent</u> that the same shall be taken by such animal.



Having charge or custody inflicts cruelty or fails to provide proper food, drink, or **protection from the weather**.





Abandons




Carries or causes to be carried in a cruel manner

Defining Animal Hoarders

- Large Number of Animals
- Failure to provide minimal standards of sanitation, space, nutrition, and veterinary care for the animals
- Inability to recognize the effects of this failure on the welfare of the animals, human members of the household, and the environment

DEFINING ANIMAL HOARDERS

- Obsessive attempts to accumulate or maintain a collection of animals in the face of progressively deteriorating conditions
- Denial or minimization of problems and living conditions for people and animals

JUSTIFICATION

ANIMALS ARE SURROGATE CHILDREN

NO ONE ELSE CAN CARE FOR THEM

WILL NOT SEEK HELP FOR FEAR OF THE ANIMALS BEING EUTHANIZED





