## Minutes

- I. The meeting was called to order at 10:05 a.m. by Colleen Mulkerin.
- II. A motion was made by Wendy Furniss to approve the minutes of the December 9, 2016 meeting. The motion was seconded by Taryn Hamre. The vote was unanimous.
- III. Patricia Trotta reviewed the updated Palliative Care and Hospice Benchmark Data which will be included in the 2016 report to the Commissioner. The data identified that CT nurses certified in Hospice and Palliative Care has dropped from 226 to 221 in the past two years. The reason for the decrease in nurse certification was discussed and reimbursement issues maybe a contributing factor. It was also identified that Connecticut has the lowest median length of stay in the nation for patients receiving the Medicare hospice benefit.
- IV. Tracy Wodatch presented an overview of current Medicare Hospice Data. It was identified that Middlesex County has the highest use of the Hospice benefit and Windham County has the least with 20-29% utilization. Medicare-benefit Hospice deaths in Connecticut were 44.7% compared to 46.6% nationally. The council members discussed the difficulty in obtaining accurate Hospice data (i.e.: Medicaid data and pediatric data). DPH working with DSS and Medicaid data for adults was obtained.
- V. A discussion was held about the development of workgroups and a timeline was established for 2017 to ensure adequate preparation of information for the 2018 legislative session.
- VI. Upcoming meeting schedule was reviewed and discussion held regarding securing a location.
