## ESTIMATED POPULATIONS IN CONNECTICUT AS OF JULY 1, 1996

Population estimates for 1996 for all Connecticut counties and towns were prepared by the Connecticut State Department of Public Health, Office of Policy, Planning, and Evaluation. The 1996 estimates are based on the estimation method described below. These estimates will constitute the basis of birth, death, and other population-based rates for 1996.

### Method of Estimation

Town-level estimates are based on three components: (1) an adjusted 1990 base population, which is added to (2) changes in group quarters, and the natural increase in population (births minus deaths), and (3) estimated changes based on four correlated statistical indicators. Each of these components is described below.

1. The adjusted 1990 base population is simply the April 1, 1990 census count plus the natural increase in population (births minus deaths) during the three month period of April-June, 1990. This adjusted figure provides a July 1 base for the annual July 1 estimate series.
2. "Group quarters" refer to institutional residences or domiciles which house populations of individuals, such as colleges, or prisons. Estimates of the population housed in group quarters are considered to be the same as in the 1990 census, except in towns that have a state or federal institution or a college with new dormitory facilities. The institutional group quarters population is adjusted by the population of constituent institutions as of July 1 of the estimate year, or, in the case of colleges, by the fall enrollment of the prior year. Birth and death data collected by the Vital Records Section of the Department of Public Health are used to calculate the annual natural increase. The 1996 population estimates use preliminary birth and death data from 1996.
3. Estimated population change is also based on correlated changes in four statistical indicators: motor vehicle registrations, voter registrations, elementary school enrollment, and housing units. Annual motor vehicle registration figures were obtained from the Connecticut Department of Motor Vehicles, and annual voter registration counts were obtained from the Connecticut Secretary of State. Changes in these raw counts between 1990 and 1996 were used to estimate associated changes in population. School enrollment data by town of residence were obtained from the State Department of Education. Data for children in grades 1-7 in October of a given year and in grades 2-8 in October of each

subsequent year were used to estimate changes in this school-age cohort. The 1996 estimate reflects the cumulative change in this school-age cohort over the one-year periods: 1989-90 through 1994-95. An adjusted change in the school enrollment figure is calculated based on the ratio of the 1990 Connecticut, town-specific number of total persons in households and the corresponding number of children enrolled in grades 1-8. This adjusted figure is used to estimate changes in population. Due to reporting changes instituted by the State Department of Education, the Fall 1995 enrollment figures reported by four regional districts were available at the district but not at the town level. Town level enrollments were estimated for each town within these four districts.<sup>(1)</sup> Net change in housing units (new building permits less demolitions) from 1990 to 1996 has been estimated on information provided by the Connecticut Department of Housing.<sup>(2)</sup> The net gain in housing units is multiplied by the estimated persons per household and by the town-specific occupancy rate (which is based on data from the 1990 census) to calculate an adjusted change in the housing unit indicator. This adjusted value is used in the final estimation process to make more precise estimates of increasing population; however, it is not used to estimate decreases in population as suggested by declines in school enrollment.

The statistical model used to estimate the net change in population due to fluctuations in each of these four indicators is based on an assessment of the association population change from 1980 to 1990 with changes in each of these indicators. Finally, the total population derived has been adjusted to conform to the 1996 Connecticut State and County estimates from the U.S. Bureau of Census.<sup>(3)</sup>

The 1996 population estimates for Connecticut's towns and counties are shown in the attached table.

**Notes**

1. These four regional school districts; (districts 10, 12, 13 and 17) involve nine towns: Burlington, Harwinton, Bridgewater, Roxbury, Washington, Durham, Middlefield, Haddam and Killingworth.
2. Household units for the 12-month period preceding July 1 are utilized. The 1996 estimates incorporate figures from 1990-91 through 1995-96. This number is adjusted to reflect the percentage of occupied units, based on the occupancy rate reported in the 1990 census.
3. "Estimates of the Population Counties: July 1, 1996, and Percent Population Change: April 1, 1990 to July 1, 1996," (includes revised March 20, 1997 census population counts). These data were released to the public with Product Announcement CB97-39, March 20, 1997. These data supersede data released with Product Announcement CB96-32.
