The contract between Bristol Community Organization, Inc. ("Contractor") and the Connecticut Department of Social Services ("Agency" or "Department"), which was last executed by the parties on effective date: 10/31/13 and previously amended on 1/23/15 is hereby *further* amended as follows:

1. The total maximum amount payable under this contract has increased by \$23,045.00 from \$1,142,013.00 to \$1,165,058.00. This one-time increase is due to the various additions and/or reductions to FFY 15 and FFY 16 budget component revisions.
2. The budget on pages 2-3 of Amendment #1 is hereby deleted and shall be replaced in their entirety by pages 2-4 of this Amendment.

All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.


