- 1. The total maximum amount payable under this contract is decreased by \$-10,402 from \$416,100 to \$405,698. This decrease is due to a 5% SFY 2015 rescissions.
- 2. The budget on page 7 of original contract shall be replaced by the budget on page 2 of this amendment.
