The contract between **Connecticut Coalition Against Domestic Violence, Inc.** (the Contractor) and the Department of Social Services (the Department), which was last executed by the parties and signed by the Office of the Attorney General on 10/03/12, is hereby amended as follows:

1. The total maximum amount payable under this contract is increased by \$223,577.00 from \$11,015,590 to \$11,239,167.00. The increase shall be disbursed as follows:
\$141,591.00 to allow carry forward from terminated contractual agreements to a consolidated DV Shelter contract. This carry forward allowance is only for dollars allocated after 7/1/2013 and unspent as of 9/30/2013 by the DV subcontractors listed below, \$59,278.00 for the FY 2014 distribution of the Marriage License funds, \$12,708.00 cost of living adjustment for direct service contractors (funds can be used only for personnel and fringe) and \$10,000.00 for Domestic Violence training identified by the department)


