WHEREAS, the Principal is an applicant or licensee as a Secondhand Dealer under Sections 10 and 11 of Public Act 11-100, and WHEREAS, pursuant to the provisions of Section 10 of Public Act 11-100 and if the following box is so checked the principal is also an applicant or licensee as a Pawnbroker under Sections 1 through 9 of Public Act 11-100, the Principal has been required, as a condition of licensure, to furnish the Commissioner of the Department of Emergency Services and Public Protection a bond satisfactory to him in the amount herein specified conditioned upon the applicant or licensee faithfully performing the duties and obligations pertaining to the licensed business and provided as indemnity for any loss sustained by any person by reason of any acts of the licensee constituting grounds for suspension or revocation of the licensee or such licensee going out of business. This bond shall cover all acts and omissions that arise during the period he surety bond is in effect. The aggregate liability under this bond shall not exceed the amount of the bond.

No. 2- The liability of the Surety may be terminated by giving thirty days written notice thereof, by registered or certified mail, to the principal and to the Commission of the Department of Emergency Services and Public Protection; and upon giving such notice, the Surety shall be discharged from all liability under this bond for a act or omission of the Principal occurring after the expiration of thirty days from the date of service of such notice.
