Fall 2005

Summer 2007

Fall 2007

- Co-Occurring Enhanced Program Guidelines completed, after statewide workgroup process
- Access to Recovery (ATR) Co-Occurring Enhanced IOPs began (25% rate increase) 16 programs
- DMHAS Recovery Times issue focuses on COD advances statewide

Winter 2008

- Large COD stakeholder meetings held at the Lyceum in Hartford, to get input on the Initiative
