This is to notify DMHAS state-operated facilities, divisions/units/offices that Commissioner Delphin-Rittmon has asked Ellen and me to send out a reminder of our formal roles and responsibilities under the Office of Multicultural Health Equity.

As you know, the functions of DMHAS Office of Multicultural Health Equity is to enhance the delivery of DMHAS services for mental health and substance use disorders in a way that acknowledges the impact of individual differences on client treatment, differences such as race, ethnic or cultural background, age, gender, sexual orientation, and physical or mental status, including communication and social protocol.

The Deaf Community views deafness as a culture and considers **deafness** as a trait, rather than a **disability**. Consistent with that view, DMHAS places the DMHAS DHOH Program under the Office of Multicultural Health Equity.

As such, the organizational structure is as followed:

- Ellen Boynton, Director, Office of Multicultural Health Equity. Ellen receives direct supervision from Commissioner Delphin-Rittmon.
- Marlene Jacques, Director, DMHAS DHOH Program. Marlene receives direct supervision from Commissioner Delphin-Rittmon.
