

Non-compliant Inspection Results August 2013

The Department of Mental Health & Addiction Services, Tobacco Prevention & Enforcement Program (TPEP) conducts tobacco compliance inspections as part of its efforts to stop the illegal sale of tobacco products to minors. The results of non-compliant inspections are forwarded to the Department of Revenue Services for administrative action in accordance with Connecticut General Statute §12-295a. Fines range from a first time offense of \$300 to the possible suspension or revocation of a tobacco license.
