

Non-compliant inspection results for the month of December 2016

State Inspectors from the Department of Mental Health and Addiction Services Tobacco Prevention and Enforcement Program conduct tobacco and electronic cigarette compliance inspections as part of an effort to stop the illegal sale of these products to minors. State non-compliant tobacco inspection findings are forwarded to the Department of Revenue Services for possible administrative action in accordance with Connecticut General Statute §12-295a. Civil penalties start at \$300.00 for a first time offence ranging to possible suspension or revocation of the license required to sell tobacco products.
