

Non-compliant inspection results for the month of June 2014

The Department of Mental Health & Addiction Services, Tobacco Prevention & Enforcement Program (TPEP) conducts tobacco compliance inspections as part of an effort to stop the illegal sale of tobacco products to minors. Non-compliant inspection findings are forwarded to the Department of Revenue Services for administrative action in accordance with Connecticut General Statute §12-295a. Fines range from a first time offense of \$300 to possible suspension or revocation of the license required to sell tobacco products.
