### APPLICATION FOR CT DMV APPROVED TRANSLATOR STATUS

#### **REQUIREMENTS:**

There are **three categories** of CT DMV-approved translators:

- 1. Independent individual translators.
- 2. Individual translators employed by a for-profit or not-for-profit organization.
- 3. Translation Businesses listed on the current State of Connecticut Executive or Judicial Branch translation contract list.

NOTE: If your business is not on the current contract list, individual translators who work for your business may apply under Categories 1 or 2.

Individual Applicants: CT DMV will include the name of the translation business you work for on the CT DMV Approved Translator List. Only an approved individual translator may translate documents for the DMV.

- 1. Fill out form completely.
- 2. Submit the following:
  - a) Individual Translators (Category 1 & 2) please submit the following along with this application:
    - Current resume showing education and professional translation experience.
    - <u>Two</u> samples of translations for <u>each</u> language (translation & original piece in foreign language). Please <u>remove</u> all Personally Identifiable Information ("PII").
  - b) Translation Business (Category 3) please submit the following along with this application:
    - Proof of current State of Connecticut Executive or Judicial Branch translation contract listing

# Connecticut Department of Motor Vehicles Approved Translator List Requirements & Information

- 1. "Approved Translator" means the CT DMV will place your name and contact information on the Approved Translator List posted on the CT DMV website. The CT DMV will not offer your name to any customer for any reason; it will be listed with all other approved translators in alphabetical order.
- 2. The CT DMV Approved Translator List posted on the CT DMV website will contain your name and languages for which you claim fluency.
- 3. If your application is approved, you will be assigned an "Approved Translator Number." This number must be included in the self-certification on each document.
- 4. All documents you translate must be a complete, word-for-word translation to the best of your ability to do so within the constraints of the language being translated. Abstract translations will not be accepted.
- 5. All documents you translate must have the following or a similar self-certification message included:

- 6. IMPORTANT: YOU MUST KEEP YOUR CONTACT INFORMATION CURRENT TO REMAIN ON THE LIST. If your contact information changes, submit a new application with the "Information Update" box checked at the top. Your name will be removed from the list if customers and the DMV cannot contact you using the information you provided.
- 7. If you no longer wish to provide translation services or want to have your name and contact information removed from the website, submit a new application with the "Remove from CT DMV Approved Translator List" box checked at the top.
