CONNECTICUT DEPARTMENT OF AGRICULTURE LICENSING UNIT UPDATE

Did you know that the Connecticut Department of Agriculture's Bureau of Regulation and Inspection issues over 15,000 licenses, permits, and product registrations through its Licensing Unit? Revenues from these licenses, permits, and registrations exceed \$1,000,000 annually.

With a staff of one full-time person and three other staff members who assist as necessary, the Licensing Unit processes more than two dozen license types. Licensees come from within Connecticut as well from throughout the entire country. Even several companies from outside of the U.S. are licensed by the Connecticut Department of Agriculture to sell products in this state.

A sampling of licenses the unit handles includes:

- pet shops
- · commercial kennels
- training/grooming facilities
- feed, seed, and fertilizer registrations
- livestock dealers
- milk laboratory analysts
- · various milk producer and milk dealer licenses

The retail milk license affects almost every Connecticut consumer. There are more than 2,900 stores that sell milk on a retail level to the public.

Effective October 1, 2011, as a result of Public Act 11-187, animal importers are required to register with the department. These rescue organizations that bring companion animals in from outside Connecticut for sale/adoption are now required to meet animal health standards similar to those required of pet shops.



In the fall of 2011, the Licensing Unit went online at https://www.elicense.ct.gov and since has transitioned the majority of its licenses to this state E-License system. The effort has been a collaboration among the Departments of Agriculture, Consumer Protection, and Public Health.

Now, in addition to being able to verify licenses issued by the Department of Agriculture, anyone can look online for the license status of individuals and companies in more than 100 job and business categories, such as electricians, plumbers, home improvement contractors, veterinarians, and livestock dealers, to name a few.

Many license, permit, and registration renewals are now processed electronically. As the system matures, it is anticipated that completion of applications and renewals will be possible via the Internet. The goal is to reduce reliance on manually entering data each license renewal cycle.

This effort has involved many months of intensive collaboration among the leadership and staff at all three agencies involved. Additional state agencies are scheduled to join the license renewal and data-reporting system soon. The online service provides a valuable resource for Connecticut residents and will reduce the amount of staff time, paper, and postage spent hand processing thousands of license applications and renewals each year.
