#### **CONNECTICUT AG WELLNESS SUMMIT**

Bureau of Agricultural Development and Resource Conservation

The Connecticut Ag Wellness Summit was held on Thursday, December 5, 2019 in South Windsor. This program was a collaborative effort between the Connecticut Department of Agriculture (DoAG), UConn Extension, Farm Credit East, the Connecticut Farm Bureau Association, the Connecticut Veterinary Medical Association, CT NOFA, and the Connecticut Department of Mental Health and Addiction Services (DMHAS).

Approximately 70 participants attended the free event which was intended for farmers, producers, and agricultural service providers, including veterinarians.

The goal of the Wellness Summit was to provide information and resources to attendees about ways to identify sources of stress, how to manage stress, and techniques for communicating with farmers who may need help dealing with stress.

"Mental health is an issue of critical importance to the agriculture industry," said Connecticut Department of Agriculture Commissioner Bryan P. Hurlburt who spoke during the Wellness Summit. "We are committed to collaborating with our partners and working together to make resources available to the support the health and well-being of our state's hard working farm families."

Speakers at the Wellness Summit included Dr. Jennifer Quammen of Veterinarian Coaching., Dr. Quammen's veterinary work is primarily in Kentucky and Indiana, with a special emphasis on surgery. She presented information about how the human brain and body are critical to success in any field.

"Taking care of animals is paramount to our success, financially and otherwise. The one animal we tend to forget is the human animal, ourselves or our family, friends and coworkers," said Dr. Quammen.

Jon Jaffe with Farm Credit East, who has 36 years of experience in agricultural lending, also spoke.

"It's not always about the finances," said Jon. "Folks can also become overwhelmed with the intense workload that can lead to burnout—physically and emotionally."

Jon grew up on a dairy farm and then owned and operated his own dairy farm for a few years. He focuses on both the personal and business aspects of estate planning and farm succession.

"Often, a financial improvement strategy is key but sometimes just getting a plan developed that defines where we are going helps put things into perspective and reduce the overwhelmed feeling," said Jon.

The Wellness Summit also included a presentation from Andrea Iger Duarte, LCSW, MPH. Andrea is the Suicide Prevention Project Director in the Prevention and Health Promotion Division of DHMAS. Ms. Duarte provided information about suicide prevention resources available in Connecticut

The Wellness Summit included a networking activity intended to promote awareness of self-care. Self-care is something done deliberately specifically to take care of our mental, emotional, and physical health. Farmers do a lot of physical

activity, but may not engage in activities to address their mental and emotional health.

In an effort to stimulate discussion during the networking activity, participants were asked to toss a small beach ball around the table with questions that include: Do you ever take a vacation? What do you do for self-care? How do you de-stress each day? Do you feel like you can talk to someone or ask for help with mental or physical health issues?

Some of the self-care ideas that were talked about at the conference were yoga, reading, hiking, listening to podcasts, exercis-

ing, and crocheting.

UConn Extension Program Assistant, MacKenzie White, helped organize the Wellness Summit, which was a follow-up to UConn Extension's Farmer Stress Support Training held in May 2019.

"We feel that this topic is critical to address in our state, and this is not a one and done program. The goal of the program was to provide knowledge and resources for our attendees to not only help themselves, but for them to help others too," said MacKenzie. "We plan to continue our efforts as a collaborative in order to provide the support that our producers and farmers need. This is just the beginning stage of what we hope to be a successful continuing program and resource for our agriculture community."

The Wellness Summit concluded with QPR (question, persuade, and refer) training; a program to aid individuals with how to recognize the warning signs of suicide. This training was provided by Joan Nichols of the Connecticut Farm Bureau Association and Willow Lake of DoAg.

Both events came from an effort by the UConn Farm Risk Management Advisory Committee to develop a program that would provide support to farmers and the people around them. The committee had identified stress as an important issue for Connecticut farmers in 2018.
