CONNECTICUT FARMERS USE RESEARCH TO EXTEND SEASON FOR FRESH CONNECTICUT GROWN PRODUCE

Bureau of Agricultural Development and Resource Conservation

As the traditional outdoor growing season comes to a close, some Connecticut farmers take advantage of season extension research and techniques to continue growing and harvesting their crops into the winter months.

Bryan O'Hara of Tobacco Road Farm in Lebanon, CT, is one farmer who has embraced season extension to bring customers fresh Connecticut Grown vegetables throughout the winter months.

"The combination of high demand in the off-season and the warmer winter weather has many growers pushing the limits of various vegetable varieties," said Bryan. "With the increase in vegetable production comes the interest in extending the seasons of growth and harvest for many vegetable crops."

Rob Durgy of the Connecticut Agricultural Experiment Station (CAES) has established a Produce Overwintering Program at CAES's Griswold Research Center in Griswold, CT, to advance our knowledge of season extension in Connecticut. The study is being funded through a \$31,620 U.S. Department of Agriculture (USDA) Specialty Crop Block Grant administered by the Connecticut Department of Agriculture (DoAg).

This research will provide farmers with information about varieties and growing techniques that will increase the volume and diversity of Connecticut Grown produce farmers can grow year-round for a steady stream of income.

"The demand for fresh local produce has increased greatly over the past decade," said Rob who is also the farm manager at the <u>Griswold Research Center</u>. "Farmers need innovative approaches to help meet this growing demand. The Produce Overwintering Program will develop novel approaches and identify vegetable varieties best suited for

twelve month production."

The first vegetables tested are broccoli and cabbage, which typically do not overwinter successfully in Connecticut. Future research will focus on other crops including beets, carrots, leeks, lettuce, radish, and Swiss chard. Several varieties of each vegetable are planted in high and low tunnels.

Low tunnel beds are about three feet wide with covers suspended with thick wipe hoops about eighteen inches off the ground. The cover is taken off mid-spring to allow full growth of the crop. Different types of covers are used at different times of year to promote growth and for insulation. The Produce Overwintering Program is using 6-mil greenhouse plastic, 1-mil perforated plastic, heavy weight winter row cover, and mid-weight row cover.

A high tunnel is a greenhouse frame with plastic cover but with no utilities and an open floor so vegetable seedlings can be planted directly into the ground. The protective cover is two layers of 6-mil greenhouse plastic inflated with air. The high tunnel has non-motorized roll-up sides and louvered vents on the end to dissipate heat. Row covers are used mid-

winter for extra cold protection.

The experiment will evaluate both high tunnel versus low tunnel production success and production viability of five varieties of broccoli and cabbage. Varieties will be statistically analyzed based on yield weight, size and marketability.

"Information on varieties abilities to survive in various temperature and exposures as well as flowering cycles is particularly needed," said Bryan who uses season extension techniques like growing vegetables in low tunnels to provide a year-round supply of produce for his customers and income for the farm.

According to Rob's research, one of the key elements to season extension is creating a small microclimate close to the ground to grow crops that would normally not grow at that time of year.

"If it's 30-degrees out, it's 60-degrees under cover," said Bryan who grows three acres of spinach, arugula, and other leafy greens under double-layers of plastic in the winter and early spring.

"We are in constant production one season to another - doesn't matter if it's winter or fall," said Bryan. "As soon as a crop is done it's turned in and we plant another one, so we're getting three to four crops a year out of a piece of land. It's very intensive and we're getting very high yields."

The ability to grow and harvest fresh Connecticut Grown vegetables during the winter allows farmers to continue selling vegetables during the off season.

During the winter months Tobacco Road Farm sells produce at the <u>Storrs Winter Farmers Market</u>, at the <u>Willimantic Food Co-op</u>, and through the <u>CT Farm Fresh Express</u> distribution facility in East Haddam. Some Connecticut farms- like <u>Gresczyk Farms</u> in New Hartford, <u>Sub Edge Farm</u> in Avon/Farmington, and <u>Provider Farm</u> in Salem- offer winter season Community Supported Agriculture (CSA) programs.

The popularity of winter season CSA programs continues to grow in Connecticut. People who are interested in eating locally grown food year round are finding farmers that use season extension techniques to source Connecticut Grown vegetables during the cold months.
