SHELLFISH GROWING AREA CLASSIFICATIONS FOR EAST LYME, CONNECTICUT

Exclusive of Niantic River, East Lyme/Waterford: See Niantic Classification 2019

Effective 12/30/19

PROHIBITED

<u>Four Mile River, Old Lyme/East Lyme</u>: That area of the Four Mile River and its tributaries in East Lyme and Old Lyme north of the Route 156 bridge.

Bride Brook: All tidal waters and tributaries of Bride Brook north of the entrance access road to Rocky Neck State Park beach.

<u>Brockett Pond</u>: All tidal waters of Brockett Pond north of the railroad bridge.

Giant's Neck Pond: That area of a pond and its tributaries located at Giant's Neck north of the Neck Road bridge.

<u>Marsh Field Tidal Creek</u>: Tidal waters and tributaries of a tidal creek at Giant's Neck along Marsh Field Road north of the Amtrak Railroad bridge.

Pattagansett River: All tidal waters and tributaries of the Pattagansett River north of the Fairhaven Road bridge.

<u>Indian Pond Tidal Creek:</u> All tidal waters and tributaries of the tidal creek from Indian Pond at Crescent Beach north of Shore Road.

RESTRICTED AREAS

Northeastern Niantic Bay, East Lyme/Waterford: That area of the Niantic Bay near the mouth of the Niantic River bounded on the north by the Amtrak Railroad bridge and bounded on the south by a line commencing at the shellfish demarcation sign located on the south shore of "The Bar" in East Lyme at a point 1,600 feet west of the mouth of the Niantic River, thence south-southeast to the navigational day marker G 1, thence east to the shellfish demarcation sign (41 19.180N 72 10.180W) located on the eastern shore of Niantic Bay in Waterford.

CONDITIONALLY APPROVED SEASONAL

Area F / Niantic Bay Special Anchorage Area: The tidal waters of Niantic Bay in the special anchorage area off Crescent Beach enclosed by a line commencing at the shellfish demarcation sign located at Crescent Beach on the eastern extremity of the point of land at the intersection of Crescent Avenue and Bayview Avenue east to navigational buoy G "9", thence southwest to the shellfish demarcation sign located on the eastern extremity of the Niantic Bay Yacht Club breakwater at a point 100 feet south of the northern extremity of that breakwater, thence west-northwest to the shellfish demarcation sign located at a point 500 feet north of the outlet from Davis (Indian) Pond. This area shall be closed to the harvesting of shellfish seasonally while this anchorage area is in use from May 1 - October 31.
