2010 AGRICULTURE VIABILITY GRANTS PROGRAM RECIPIENTS

A total of 81 Agriculture Viability Grants were received by the application deadline last fall. A total of 36 grants were awarded to 20 producers, 1 coop, 10 agricultural non profits and 5 municipalities. These annual grants help finance on-farm improvements and fund many programs that support and promote Connecticut agriculture. Funding is not limited to production farmers. Non-profit organizations and municipalities also are eligible for the grants if agricultural components are involved. The grants are awarded on a competitive basis and matching funds must be supplied by the applicant. Recipients may receive up to \$49,999 in matching funds and have one year to complete their project. The grant recipients fall into 2 separate categories; the Farm Transition Grants (for producers and agricultural co-ops) and the Farm Viability Grants (for municipalities and agricultural non-profits). Each grouping has a dedicated fund of dollars.

The Agricultural Viability Grants are made available through Public Act 05-228, An Act Concerning Farmland Preservation, Land Protection, Affordable Housing and Historic Preservation. This landmark legislation serves to protect and preserve Connecticut for future generations by providing funding for municipal open space grants, farm viability and preservation, historic preservation and new and existing affordable housing programs, along with new infrastructure to support and promote agriculture in the state. This funding is generated from a \$40 fee collected by town/city clerks for the recording of all documents into municipal land records. Documents subject to this fee include deeds, mortgages, mechanics' liens, judgment liens, notices of lease, releases of mortgages and liens, name change certificates, notices of variances, and condominium declarations.

These grants help fuel an important component in our state economy. Agriculture is a diverse \$558 million dollar industry with over 4,900 farms in Connecticut (2008 USDA- Agricultural Statistical Service). This years grants range from Community Supported Agriculture, maple sugar processing facilities, orchard expansion, new goat dairy and more. THE DAIRY INDUSTRY IN CONNECTICUT

According to a 2007 report by two state agencies and UCONN:

Connecticut's dairy industry (including processing) generated an estimated \$1 billion in statewide sales and accounted for approximately 3,500 jobs taking into account effects on related businesses

- Dairy processing establishments had direct sales of nearly \$500 million, with about half of that being sales of cheese and yogurt, and the remaining in fluid milk, ice cream and frozen desserts, and manufacturing.
- 25 dairy processing establishments including 11 milk bottlers and
 4 cheese manufacturers

Additional Dairy Farming Statistics for 2007:

- 159 dairy farms located in 75 CT towns
- CT dairy farms operated 72,000 acres of land accounting for 20% of the state's land in farms
 - In 2007, CT dairy farms had direct sales of \$76 million
- 19,000 milk cows produced 355 million pounds of milk or18,684 pounds per cow

SPRING OPEN HOUSE 2010 A SUCCESS

The Connecticut Agricultural Experiment Station (CAES) recently invited interested citizens, legislators, and the media to their annual Spring Open House. This year's topic, Conservation: Management of Invasive Insects and Plants, was selected to raise the awareness of Connecticut residents about the importance and prevalence of invasive plants and insects in the state. Invasive species are a real threat to our environment and economy

and can have potentially severe, often irreversible impacts on agriculture, recreation, and natural resources. They also threaten biodiversity, habitat quality, and ecosystem function. This public event highlighted the resources and expertise offered by the Experiment Station staff to assist homeowners, land managers, and others interested in preserving natural areas with recognizing and managing invasive species and with making sound choices for selecting native plants for their landscapes.

Dr. Louis A. Magnarelli, Director of CAES, welcomed everyone to this yearly public event, which featured information on recognizing and managing invasive species. "The Experiment Station has assisted Connecticut residents since 1875 by providing research-based information on all aspects of plants and agriculture and today's event on the potential impacts of invasive species is of particular importance to our stakeholders," said Dr. Magnarelli.

Attendees heard short presentations on (1) "Biological Control of Hemlock Woolly Adelgid and Mile-a-Minute Weed in Connecticut," (2) "Connecticut's Invasive Aquatic Plants: Searching for Solutions," and (3) "Plants for the Landscape: Native or Exotic?" Attendees of guided tours learned about the role of marsh crabs and plant pathogens in Sudden Vegetation Dieback of Connecticut's salt marshes, how controlling barberry helps to reduce tick populations, and how to identify invasive and native plants. There were displays and information about the Asian Longhorned Beetle and publications on many topics, including gardening, seed testing, and new ethnic and exotic crops. Experts also answered questions on plant identification and disease diagnosis, soil testing, and weed and insect identification-all important to maintaining a healthy environment.

Connecticut Sea Grant and the Connecticut Seafood Council have teamed up to offer you insulated bags at cost, for resale to your customers.


The bags serve the dual purpose of keeping seafood purchases cold and safe while promoting local seafood. They are great for farmers markets and retail operations.
