Gene Gantz, Risk Management Agency, USDA Crop Insurance Specialist

This Risk Management Tool is a way for dairy producers to insure their milk income reflects unexpected changes of the milk price or the cost of feed. The insurance policy provides protection against losses of the dairy farmer's "gross margin" (or the value of milk minus the feed costs). The policy uses future prices for corn, soybean meal, and milk to determine the expected gross margin and the actual gross margin. The indemnity paid is the difference, if positive, between the guarantee and the actual gross margin.

**FUNDING OPPORTUNITY
FOR ON-FARM ENERGY AUDITS**

TOLLAND, CT— Have you ever wondered about what techniques you could utilize to reduce the amount of energy used on your farm? The USDA-Natural Resources Conservation Service (NRCS) may have the answer. Through the Environmental Quality Incentives Program (EQIP), NRCS is now offering the opportunity to help you obtain an energy audit at your farm's headquarters, greenhouse, maple sugar house, or on cropland.

An Agricultural Energy Management Plan (unique to the farm's headquarters and/or cropping operation) will be developed to assist an owner/operator to know what techniques or equipment can be used to reduce energy use and save money. The plan will be designed by a Technical Service Provider (who is certified by NRCS and placed on an approved list) who will provide technical assistance for specific conservation programs administered by USDA.

Through EQIP, NRCS will pay up to 75% of the cost of an Agricultural Energy Management Plan based on the number of animal units, square feet of greenhouse, maple sugar taps, or acres of cropland.

Applications will be accepted on a continuous basis; however, the next cutoff date for funding is June 15, 2010. Applications will be funded as re-quests are received and eligibility has been determined.

Since 1935, NRCS has provided leadership in a partnership effort to help America's private land owners and managers conserve their soil, water, and other natural resources. NRCS employees provide technical assistance based on sound science and that is suited to a customer's specific needs, and provides financial assistance for many conservation activities.
