GOOD AGRICULTURAL PRACTICES (GAP) & GOOD HANDLING PRACTICES (GHP) AUDIT PROGRAM

Through a Federal-State agreement, the Connecticut Department of Agriculture (CT DoAG) is now offering USDA-GAP/GHP audits. This is a voluntary, audit based program that verifies adherence to the recommendations made in the Food and Drug Administrations (FDA) Guide to Minimize Microbial Food Safety Hazards for Fresh Fruits and Vegetables. This program is not mandated by any government agency. Many institutions, wholesalers, and retail operations are now requesting farmers/processors they work with to get a third party audit. Different food safety audits are available through different third party auditing firms (USDA, Primus, SQF, etc). These auditing firms may have different requirements to successfully pass the audit. Please check with the company that is requiring the GAP/GHP audit to determine what third party auditing firm to use. Also check the scopes or parts of the audit that is to be reviewed.

This USDA GAP/GHP program is broken down into three major sectors:

- Good Agricultural Practices (GAP) which examines farming practices
- Good Handling Practices (GHP) which concentrates on packaging, packaging facilities, storage facilities and wholesale distribution centers
 - · Food Defense protocols utilized throughout the food chain.

Each audit process will include:

- A review of the Farm/Businesses Food Safety Manual which includes the farm/businesses Standard Operating Procedures (SOP)
- The initial visit to review specified scopes and verify SOPs are being followed
 - At least one unannounced follow up visit as required by the program
 The USDA GAP/GHP Audits cover the following scopes:
 - General Questions (required part of every audit)
 - Part 1 Farm Review
 - · Part 2 Field Harvesting & Packing Activities
 - · Part 3 House Packing Facility
 - Part 4 Storage & Transportation
 - Part 5 Currently Unavailable
 - Part 6 Wholesale Distribution Center/Terminal Warehouse
 - Part 7 Preventative Food Defense Procedures

The requesting farm/business notifies CT DoAG Auditor which part(s) they wish to have covered during the audit(s). In order to pass the GAP/GHPAudit, a score of 80% or better in ALL of the requested scopes is required. A farm/business will fail an audit if an 80% score on any one scope is not achieved or if during the audit any "automatic unsatisfactory conditions" are found.

Upon completion and achievement of satisfactory score, the farm/business will receive a certificate from the USDA-AMS and be listed on the USDA-AMS website. This listing shows all farms/business that have successfully passed the USDA-GAP/GHP audit and which parts of the audit are covered. The audit results are valid for one year.

Preparation & Education:

Before requesting an audit, it is highly recommended the requesting farm/business do a self audit. The actual checklist used during the USDA-GAP/GHP audit is available at the USDA-AMS website. CT DoAG cannot make recommendations on how to bring your farm/business into compliance to pass an audit. Fees: The cost of the USDA GAP/GHP audit is \$92.00 per hour plus a \$50.00 administration fee. These fees are billed following the completion of the requested audit.

Through the USDA Specialty Crop Block grant the CT DoAG is offering a GAP/GHP Cost Share Grant. Farms/businesses that successfully pass an audit from an accredited third party auditing firm can receive 50% (up to \$500) for the cost of the audit. For more information on the GAP/GHP Cost Share
