Statutory Authority: Conn. Gen. Stat. §12-264(b)(3).

Effective Date: March 1, 2005.

DRS-Registered Natural Gas Suppliers: A *DRS-registered natural gas supplier* is a natural gas supplier registered with DRS for purposes of the tax imposed under Chapter 212 of the Connecticut General Statutes (the Utility Companies Gross Earnings Tax).
